LOCAL LAW NO. 1-1956 CHAUTAUQUA COUNTY

A Local Law Amending Section 5 of Chapter 780 of Laws of 1950 and Local Law No. 1 of the Year 1952 of the County of Chautauqua Relating to the Licensing, Registration and Collection of License Fees Annually by the County of Chautauqua for Power Boats; and Including Therein Certain Boats Propelled by Sails; and Including Therein Authority for the Appointment of Agents for the Issuance of Licenses; and Including Therein Requirements for Filing Certificates of Ownership for Certain Boats

BE IT ENACTED, by the Board of Supervisors of the County of Chautauqua as follows:

Section 1. Section 5, paragraph 4 of Chapter 780 of the laws of 1950 is hereby amended to read as follows:

To license, register and collect annually for the County of Chautauqua the following fees for licenses issued o any boat propelled by a motor, whether privately operated or used for hire: [a. for such boats less than 16 feet in length, 75c]; <u>a. for such boats less than 15 feet in length, \$1.25; b. for such boats 16 feet or more but less than 26 feet in length, \$1.50; <u>b. for such boats</u> <u>15 feet or more but less than 18 feet in length, \$2.25</u>; (c. for such boats 26 feet or more in length, \$5.00) <u>c. for such boats 18 feet or more but less than 23 feet in length,</u> \$4.25; d. for such boats 23 <u>feet or more but less than 28 feet in length,</u> \$7.25; e. for such boats 28 feet or more in length, \$10.25.</u>

<u>Section 2-a</u> To license, register and collect annually for the County of Chautauqua the following fees for licenses issued on any boat propelled by means of sails; a. for such boats 14 feet over in length, measured from stem to stern, \$2.25.

Every boat licensed under this act shall have attached in a conspicuous place to the stern thereof a yearly number plate to be provided by the Commission. Such number plate shall be displayed at all times during the current year that said boat is licensed. In the event that a number plate becomes lost or destroyed a new license and number plate for the boat for which such license was issued shall be re-issued for the sum of 50c.

Section 2-c. The Commission may appoint agents with authority to issue licenses and number plates on its behalf. Each such agent shall be appointed only for the current year in which said appointment is made. Each such agent shall file reports and make remittances to the Commission as it shall direct. Any such appointments may be revoked with or without cause at any time by the Commission. Such agents shall retain from the fee for each registration or license a sum to be fixed by the Commission annually, not to exceed the sum of 25c. The Commission shall file a certificate with the County Treasurer fixing the sum to be retained by such agents each year before any licenses may be issued by any such agent. The Commission shall also file a certificate of appointment of each agent with the County Treasurer before any licenses may be issued by any such agent.

Section 2-d. All expenses incurred by or for the Commission for number plates, license forms, application forms and the like, shall be chargeable by the County Treasurer to the Commission.

Section 2. Section 5, paragraph 3 of Chapter 780 of the laws of 1950 is hereby amended to read as follows:

To collect an additional fee for inspection of all boats which require licensed pilots in order to carry passengers at the rate of 75c per passenger capacity and said inspection shall not be less than \$5.00 nor more than \$30.00 in any event; on all other boats for hire the sum of 50c per boat, except that where a boat livery is maintained such fee shall not exceed \$5.00 for any one livery. No license shall be issued for any boat which requires licensed pilots in order to carry passengers until a certificate of ownership has been filed with the Commission. If such boat be individually owned, or owned by a partnership such certificate shall be signed by such individual or by at least one of the partners. If such boat be owned by a corporation or association, such certificate shall be signed by an authorized officer thereof.

Section 3. This Local Law shall take effect immediately.
