

LOCAL LAW NO. 3-1969
CHAUTAUQUA COUNTY

A Local Law Providing an Increase in Pay Schedule

BE IT ENACTED, by the Board of Supervisors of the County of Chautauqua as follows:

Section 1. Whereas, Resolution No. 201-69 entitled "Authorizing Compensation Increases for County Officers" has been introduced before this Board and which resolution provides for increases in the current pay schedules effective January 1, 1970, and whereas said resolution according to law does not become effective as to certain officers during their term of office, therefore, this local law is enacted for the purpose of making said increases effective as of January 1, 1970 to such county officers.

Section 2. That the current pay schedules covering the positions of County Clerk, District Attorney, and Sheriff be and hereby are increased eight percent effective January 1, 1970 and said schedules as adjusted are hereby increased five percent effective January 1, 1971, and said schedules as further adjusted are hereby increased five percent effective January 1, 1972, all computed to the nearest cent, except that for the year 1970, no increase shall exceed the sum of \$1000.00.

Section 3. That the current salary and hourly pay schedules for all other departments heads, elected officials and county officers who have the power to appoint subordinate personnel except members of the judiciary be and hereby are increased eight percent, computed to the nearest cent, effective January 1, 1970, except that no increase shall exceed the sum of \$1,000.00.

Section 4. That the provisions of Resolution No. 201-69 are hereby made effective to all department heads, elected officials and county officers who have the power to appoint subordinate personnel except members of the judiciary.

Section 5. This Local Law shall take effect immediately.

A Local Law Providing an Increase in Pay Schedules

Be It Enacted by the Board of Supervisors of the County of Chautauqua as follows:

Section 1. Whereas, Resolution No. 200-69 entitled "Authorizing Compensation Increases for Employees and Officers" has been introduced before this Board and which resolution provides for increases in the current pay schedules effective January 1, 1970, and January 1, 1971, and whereas said resolution according to law does not become effective as to certain officers during their term of office, therefore, this local law is enacted for the purpose of making said increases effective as of January 1, 1970, and January 1, 1971, to such county officers.

Section 2. That the current salary and hourly pay schedules for all positions and steps of employment in Chautauqua County service, except County Clerk, District Attorney, and Sheriff be and hereby are increased eight percent, computed to the nearest cent, effective January 1, 1970.

Section 3. That the salary and hourly pay schedules effective January 1, 1970 for all positions and steps of employment in Chautauqua County service, except County Clerk, District Attorney and Sheriff be and hereby are increased effective January 1, 1971 by the percentage increase granted under agreement with Chautauqua County Chapter of the Civil Service Employee's Association, Inc. and effective January 1, 1971 and computed to the nearest cent.

Section 4. That the provisions of Resolution No. 200-69 are hereby made effective to all County Officers, expect members of the judiciary.

Section 5. This Local Law shall take effect immediately.
