LOCAL LAW NO. 11-91 CHAUTAUQUA COUNTY

A LOCAL LAW PROVIDING FOR THE ESTABLISHMENT OF FEES FOR CERTAIN COUNTY OF CHAUTAUQUA DEPARTMENTS

BE IT ENACTED, by the County Legislature of the County of Chautauqua as follows:

Section 1. Fees.

The County of Chautauqua is hereby authorized and empowered pursuant to State law to collect the following fees:

A. Probation Department

Fees for custody investigations, visitation investigations, and alcohol/drug testing shall be collected by the Chautauqua County Department of Probation. Such fees shall be based on the parson's ability to pay, and may be waived in whole or in part at the discretion of the Directory of Probation pursuant to rules and regulations and in accordance with State law determined by the Chautauqua County Executive.

The fees to be charged are as follows:

Alcohol/Drug Testing			\$ 10.00

No fees shall be charged in any action in which the Chautauqua County Department of Social Services is named as Petitioner or Respondent.

B. Central Services

The Director of Central Services shall collect fees for use of Chautauqua County fax machine by non-County employees for outgoing documents as follows:

\$3.00 for the 1st page \$1.50 for each succeeding page

Said services shall be made available at the discretion of the Director of Central Services.

C. Department of Planning

The Director of Planning shall collect the fee of \$10.00 for processing and responding to Federal Emergency Management Administration (FEMA) designated floodplain information requests.

D. Department of Health

- i. The Commissioner of Health shall collect fees for the vaccination of cats for rabies as follows: \$5 per cat or \$10 per family for up to three (3) cats.
- ii. The Commissioner of Health shall collect fees for influenza vaccination for humans as follows: \$5 per shot, unless prohibited by statute or duly adopted regulations. Said services shall be made available at the determination of the Commissioner of Health.

Section 2. Collection of Fees.

The procedure for the collection of such fees shall be as prescribed by the appropriate laws of the State or as determined by the Chautauqua County Executive.

Section 3. Effective Date.

This local law shall take effect immediately upon filing with the New York Secretary of State.
