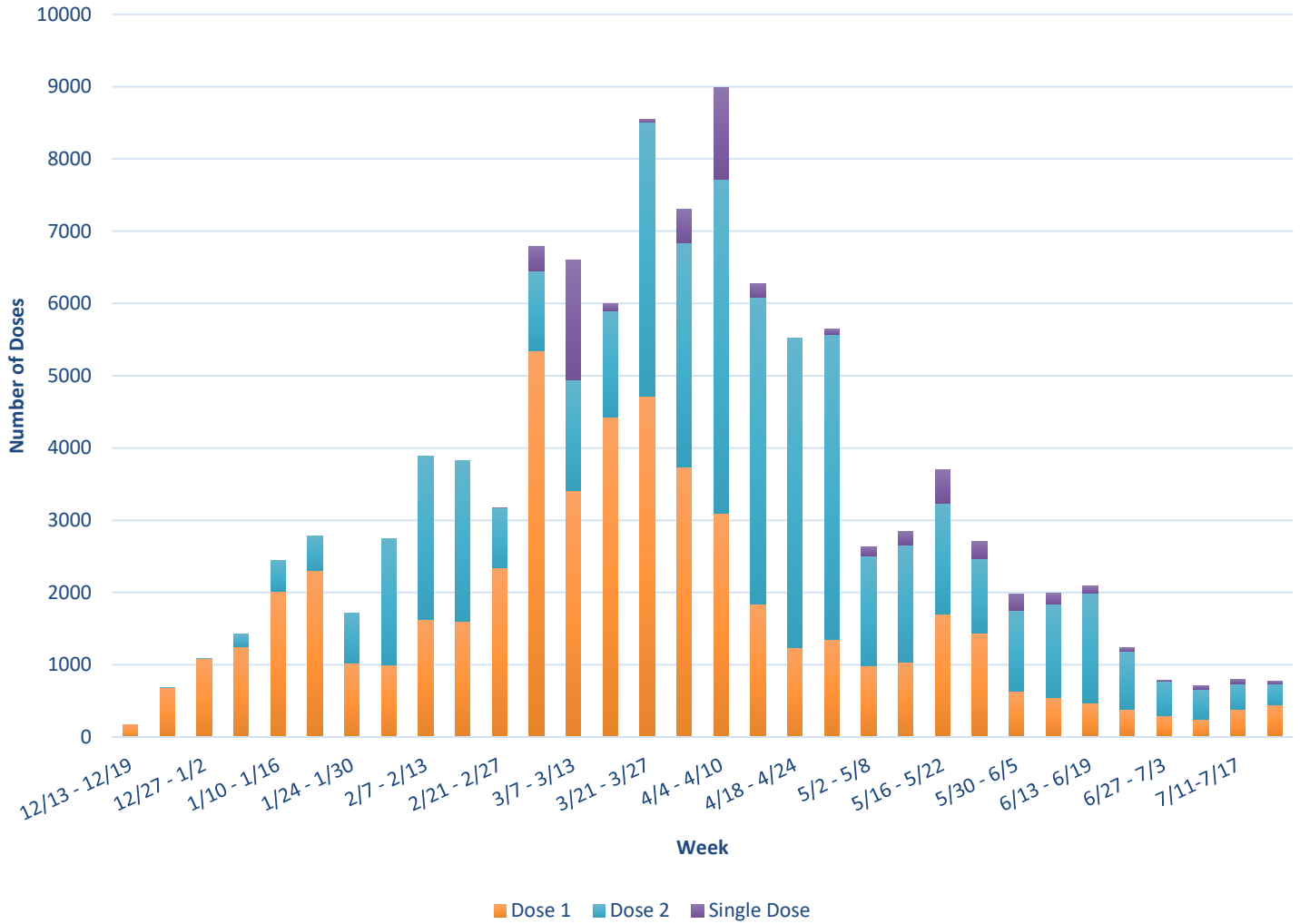

## Chautauqua County Residents with At Least One Dose of Vaccine by Age Group

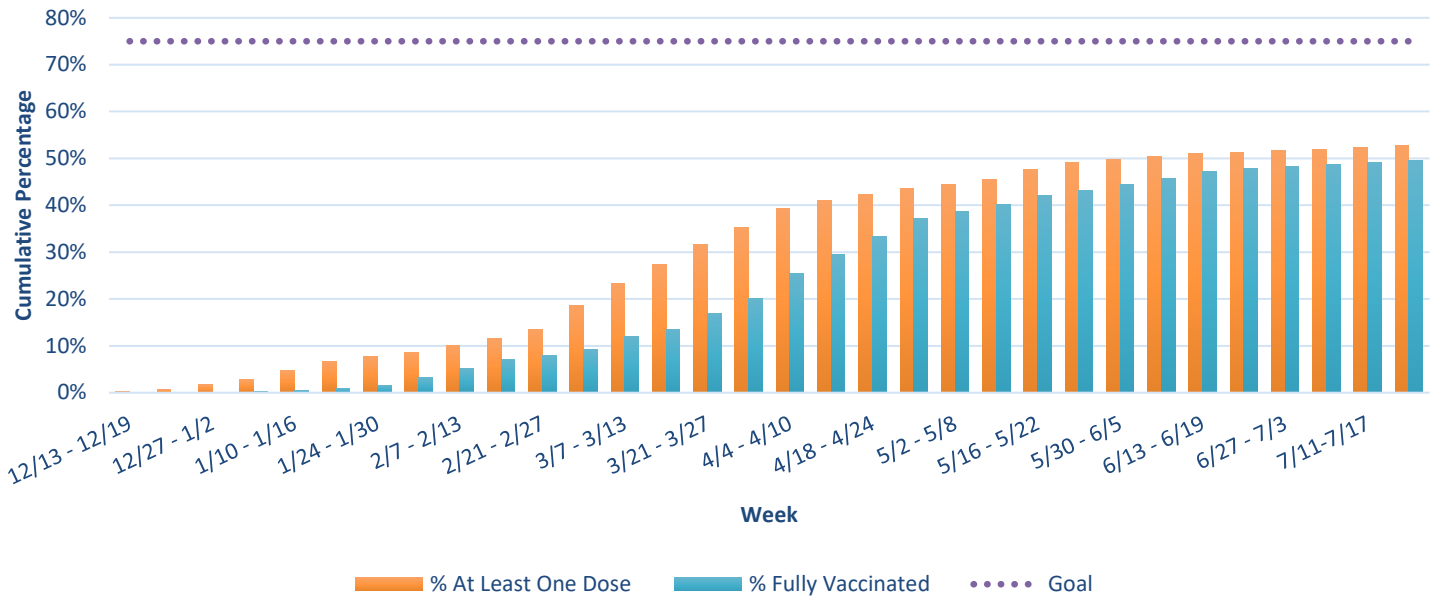
