# 226-22 Acceptance of FAA Funds for the Runway 15-33 Lighting Improvements (MIRL/REIL/Wind Cones) Construction at the Chautauqua

Chairman Chagnon: Thank you. So Shannon, since this resolution has not had the opportunity to go through committee, would you please explain it to us?

Shannon Barnhart: Sure. We're looking to upgrade the lighting on the primary runway – I'm sorry on the cross runway at Dunkirk. So (*inaudible*) intensity runway lights (*inaudible*) identifier lights and they will be upgraded to LED per – I don't know because I didn't look at the requirements from our cert officer but it is a requirement that we have them all working. I'm just unsure from last year if this is where it came from so we have already approve the project. We've already bid the project and this is just for the acceptance of the grant funding.

Chairman Chagnon: Are there any questions or comments on this resolution?

Kathleen Dennison: I have a comment that unfortunately I made a typo in the resolution. So where it says "increase capital appropriation account" that amount should be \$744,351. So it would be equal to the sum of the revenue accounts.

Chairman Chagnon: Everybody okay with that? The motion to treat that as a typo and make that change to the resolution.

Legislator Harmon: I'll make that motion.

Legislator Rankin: Thank you. Given the fact that this grant will pay 90% of the allowable cost.
