TITLE: Authorize Public Hearing Regarding a Potential Application for 2025 CDBG Funding through NYS Office of Community Renewal

AT THE REQUEST OF: County Executive Paul M. Wendel, Jr.:

WHEREAS, the Office of Community Renewal is expected to release a Notice of Funding Availability (NOFA) for the 2025 Community Development Block Grant (CDBG) program, a federally funded program authorized by Title I of the Housing and Community Development Act of 1974, under its Housing Resources NOFA, during summer 2025; and

WHEREAS, the CDBG Program Housing Resources program provides funding to eligible communities for housing activities including housing rehabilitation, homeownership, manufactured housing rehabilitation or replacement, well and septic replacement, and lateral connection assistance that primarily benefits low- and moderate-income persons; and

WHEREAS, the County is considering applying for funding for the Chautauqua Septics and Wells Program, under this NOFA, for those residing in eligible, non-entitlement communities within Chautauqua County; and

WHEREAS, the County seeks public input on community development, housing needs, and proposed activities under the CDBG program, especially input from low- and moderate-income residents; now therefore be it

RESOLVED, That the Chautauqua County Legislature hold a public hearing for the aforementioned purposes during the regular meeting of the County Legislature on August 27, 2025, at 6:35 p.m., in a manner consistent with CDBG program requirements; and be it further

RESOLVED, That the Clerk of the Legislature is authorized and directed to post notice of the public hearing in the Gerace Office Building and to publish notice of the hearing at least seven (7) days prior thereto in the official newspapers of the County of Chautauqua in such form as is approved by the Chautauqua County Law Department.

TITLE: Authorize an MOU with New York State Department of Health Office of Sexual Health and Epidemiology for participation in the 340B Drug Pricing Program as a Sexually Transmitted Disease Entity – Health Department

AT THE REQUEST OF: County Executive Paul M. Wendel, Jr.:

WHEREAS, the Chautauqua County Health Department (CCHD) strives to promote and protect the health of residents by providing sexual health education and services; and

WHEREAS, the 340B drug pricing program (340B), managed by the United States Health Resources & Services Administration Office of Pharmacy Affairs, is designed to stretch scarce federal resources as far as possible, reaching more eligible patients and providing more comprehensive services; and

WHEREAS, New York State Department of Health (NYSDOH) Office of Sexual Health and Epidemiology (OSHE) is eligible to participate in the 340B program and is able to confer 340B program eligibility to qualifying Sexually Transmitted Disease (STD) clinics and other eligible organizations who receive in-kind support purchased with CDC STD Prevention and Collaboration for Health Departments grant funds; and

WHEREAS, CCHD participates in the 340B program by receiving in-kind service of safety-net testing, access to laboratory testing for chlamydia, gonorrhea and syphilis at no cost for uninsured or underinsured patients through the NYSDOH contracted laboratory, educational materials, and/or condoms; and

WHEREAS, as part of an ongoing process to re-affirm procedures for conferring program eligibility, the NYSDOH OSHE now requires a Memorandum of Understanding in order to receive the in-kind services; now therefore be it

RESOLVED, That the County Executive is hereby authorized to enter into a Memorandum of Understanding between Chautauqua County and the NYSDOH OSHE for participation in the 340B program as an STD entity for as long as the CCHD is eligible to receive the services associated with the 340B program.

TITLE: Accept Enhanced Drinking Water Grant Funding

AT THE REQUEST OF: County Executive Paul M. Wendel, Jr.:

WHEREAS, the Chautauqua County Health Department strives to prevent illness and disease by ensuring public drinking water meets the required standards set by the New York State Department of Health (NYSDOH); and

WHEREAS, the NYSDOH has awarded \$128,899 per year in grant funding to the Chautauqua County Health Department for the Enhanced Drinking Water Program for the period 4/1/25 to 3/31/30; and

WHEREAS, this grant will enable the County to ensure drinking water from public water supplies is as safe as possible and that the County's drinking water program complies with New York State requirements; and

WHEREAS, no matching funds are required for this grant and the 2025 portion is included in the 2025 Budget so an amendment is not necessary; now therefore be it

RESOLVED, That the County Executive is hereby authorized to enter into agreements with the above-named grantor for funding on an annual basis for so long as the county Health Department continues to be funded by this program, with work plans and budgets to be amended and revised on a yearly basis by letters of agreement between the parties; and be it further

RESOLVED, That the County Executive is hereby authorized to enter into agreements with agencies and organizations as necessary to carry out the objectives and requirements of this grant program.
