Call to Order	The meeting was called to order at 6:01 p.m. by Kidder.		
Privilege of the Floor	Gene: My name is Gene Palmer. I just wanted to share some more of the experiences I've had with healthcare in Chautauqua County. Would anybody offer to ask Dr. Berke why he's violated my HIPPA rights refusing to respond to a request for an amendment? I mean, I've had these live falsifications on my record for seven years now.		
	Kidder: Okay. We don't respond during this session; this is your opportunity to present to us. So, you can just continue.

Nothing but falsifications, too, stating I was taken back to an exam room, but at least I had a letter from the hospital stating I was there that day, even though it was all lies. I give him the letter stating I was there that day after he gave me a non-compliant letter. Katherine (inaudible), one of the nurse practitioners, called me up demanding to want to		

know why I didn't go to the hospital. I recorded the call. I was in my car coming back from the hospital on my dash cam. I played the recording for her. I gave these papers that you have there in the center of the table to Dr. (inaudible) and Katherine (inaudible). Explicit instructions to give to Dr. Berke, Buerke, They found their way in the garbage. Okay. Couple months later, I stop into his office, give the same papers to the manager. I'm expecting to be discharged. I mean, I'm not hearing nothing. Not hearing nothing. I'm expecting to be discharged. Finally, I get after I deliver them personally to their office manager and in his letter, he writes me back, I read the letters you left in my office on such and such date, which implies that where did the letters go that I gave Katherine (inaudible)? I had her to listen to the conversation of her lying and falsifying my records in the garbage. He didn't get any of according to his own words. I read the letters he left at my office on June 20th. Okay, I reached out to other people. I sent basically a lot of this same stuff to Lacey Wilson. I contacted Carmelo Hernandez, asked if anybody from his office could reach out me. No response from anybody. You know, your motto is what is it? prevent, promote, protect. I think you're walk talking the talk, but I don't know if you're meeting walking the walk. Okay. So, does anybody Oh, you don't respond. Okay. I was going to ask if anybody has any suggestions on what I can do. My last three providers I've had in a row have violated my HIPPA rights. Either one by refusing to give me a copy of my own records. Why? Because I have them on tape also lying, falsifying my records. I mean, what is a person supposed to do? I mean, this is just this is disgusting. I look at people in healthcare now, all people in healthcare are low lives. I'd be more likely to get reliable, honest information from used car salesman. This is a joke. You know, this is a joke. This was a freaking joke. -Boil Water Orders (BWO)

Our department's role in BWO's

- We amplify the order, including safe use information, on behalf of the water source/operator.
- We send out the NY Alert notifications received via text, phone or email (depending on preferences the resident sets during sign-up).
- Our Water Specialists/staff provide technical assistance, troubleshooting additional concerns and issues.
- We offer CCHD lab as an option for them to complete microbiological sample analysis.
 - Facilities, though, do not have to use our lab.
 - If we do process samples, we communicate water test results.
 - -If a private lab is used then the results of the testing must be communicated to our department before the BWO can be lifted.
- · We amplify the lifting of the BWO and other necessary or helpful instructions/information at that time.

-2026 Budget

- A primary focus of our departmental 2025-2027 strategic plan is departmental efficiency.
- The division leads have planned well and we have contingency strategies in place to ensure that there are no major shifts in the budget despite funding concerns.
