By Public Facilities, Planning and Economic Development and Audit & Control Committees: At the request of County Executive Paul M. Wendel, Jr.:

WHEREAS, at the Request of the County pursuant to Resolutions 180-95 and 188-95, the Chautauqua County Industrial Development Agency (CCIDA) constructed Hangar A at the Chautauqua County Airport – Jamestown utilizing the proceeds of a CCIDA bond purchased by the County; and

WHEREAS, bond payments by CCIDA to the County were made by applying Hangar A rental revenue received by CCIDA, but commencing in 2020, the County has itself directly negotiated leases for Hangar A and directly received the rental revenue; and

WHEREAS, in recognition of the County taking over the negotiation of the Hangar A leases and directly receiving the rental revenue, the County and CCIDA in January 2023 agreed to terminate a ground lease agreement between the parties, pursuant to which the County leased to CCIDA the land on which Hangar A was constructed; and

WHEREAS, ownership of Hangar A thereby automatically transferred to the County under the express terms of the lease terminated in January of 2023: "All alterations, improvements, additions, or fixtures installed by CCIDA, . . . including the storage hangar, shall become the property of the County upon the termination of the Lease for any reason"; and
