Legislator Larson: Thank you, Mr. Chairman. I apologize for this chair, its never squeaked like this before. The American Rescue Plan – I was not a member of the Legislature at the time of having the ability to influence how President Biden's 26 million dollars, I think it was 26 million dollars to Chautauqua County was spent. My impression though is that the County Government, Legislature, Executive, Department Heads - my impression is that his County spent the 26 million dollars well and it was a rare circumstance where essentially the Biden Administration supportive majority in congress, gave this money out to municipalities to use their best judgment as to what long term benefit would be had for their communities make up their own minds. As I understand, very few strings were attached and here tonight we're still benefiting adding into 2026, 2027, we're still benefiting in the next Legislature in this case, interest earnings from the ARPA funds. Never is a long time but it's a pretty good guess that at least those of us with 7 decades or so on our resumes, we'll never see the federal government send municipalities like Chautauqua County 26 million dollars again and trust us to do the best with it that we determine on our own. It was a great opportunity and my impression is that the Legislature used that 26 million very well, thank you.

Legislator Larson: Thank you, Mr. Chairman. My comment really applies all 5 of these resolutions. At the Economic Development Committee meeting last Wednesday evening, through questioning of the folks in front of us, none of these 5 resolutions which use words such as attraction, development, business development, assistance, promotion. None of them offer any funds for job training and I am concerned heading into 2026 as a legislator coming back here, I want our Economic Development Committee to explore what is going on with JCC in terms of job training in the north county? (*Inaudible*) what is the future of job corps in Cassadaga. To me, attracting new businesses, retaining businesses, the county and its IDA offering some job training resources on a consistent annual basis is critical and I supported all 5 of these resolutions in our committee meeting but the fact is, there really is no money in our 300-million-dollar 2026 budget for job training including there's no money in these 5 resolutions. Thank you, Mr. Chairman.

Hi, Good Evening, my name is Anthony Toda and I live at 144 Clifton Avenue, Jamestown, New York. I'm making my opinions and part based on media reports. It is our moral duty and obligation to contact all of our federal representatives for continuing economic and military support for Ukraine. Reports state that close to 2 million Russian soldiers have died and massive amounts of Russian military equipment has been lost. Putin's propaganda lies are intended to give the rest the impression that Russia can continue this (*inaudible*) indefinitely. Russia cannot continue to fight a protracted war in Ukraine as long as military support from the U.S. continues. In the Russian Afghanistan war, Russians Vietnam, multi support from the U.S. (*inaudible*) Russian personnel equipment and Russia had to withdrawal. With U.S. continued

military support, the same thing will happen in Ukraine. At this critical time, don't allow this (*inaudible*) of Putin's lies to steal land from Ukraine because Russian military has been so depleted, that Russia will eventually have to withdraw from this war. Now regarding the Brown University shooting, when are Americans going to realize that federal agencies been on destroying the second amendment provided an avenue for the shooter to enter an unprotected area as has been the case historically and recently. The state criminals imbedded in the FBI in order of (*inaudible*) government agencies, masterminding crimes by using millions of our tax dollar. FBI began violating my rights and assaulting me 3 decades ago. When I called the FBI Buffalo to complain, one of the many sick responses to me was "I'm going to blow your genitals off". Fran was obviously well liked by the people of Brocton and Portland and he was just a people person just like me. Everybody loved Fran, everybody did. It was a 25-member legislature then and if there was a vote for most lovable legislature, I think Fran would have won every year. Not only was he a great person and so kind, but he was a – an addition to being a Yankees fan, as a North County legislator, I had the privilege of sitting with him many times in the College stadium in Jamestown. He was a great fan of minor league New York Penn baseball in Jamestown and he made that drive from Brocton to come down and enjoy a beautiful summer evening ball game in the great City of Jamestown. I had the privilege of continuing to know him after my time ended as County Attorney in 2005 so I thank you for letting me just say some kind words about a great wonderful man and the fact that he lived to be 92 and so did Dick Babbage, I find that very encouraging, Mr. Chairman. Thank you.

Good evening, my name is Tammy Schack, a resident of the Town of Ellery and a Director of Chautauqua Lake Property Owners Association, the CLPOA. I appreciate the opportunity to speak with you about the Lake once again. The CLPOA's next public meeting, "Wetlands" public meeting #14 is our sixteenth and will be held Saturday, January 10, 2026 from 9:30 to 11:00am at the Lawson Center in Bemus Point. We recall seeing Mr. Penhollow at one of our early meetings and we hope more of you especially the lakeside legislators, Mr. Penhollow, Ms. Vanstrom, Ms. Gustafson, Mr. Proctor and Mr. Chagnon along with County Executive Wendel we invite you to attend this meeting. We promise you will get a valuable prospective on some Lake issues that you are not going to get as a county representative. Some of you have referred to the CLPOA as an advocacy group to differentiate us from the 3 lake maintenance organizations. The Chautauqua Lake and Watershed Management alliance funds those 3 with hundreds of thousands of dollars each year and will soon grant 6 alliance boards

seats to them. In that context, we do not argue with the advocacy group characterization of the CLPOA. In fact, we in our almost 500 supporters, cherish our independence from the County and State funding and DEC therefore permitting influence in our ability to tell it like it is. The Chautauqua Institution is also an advocacy group but with a formal fiduciary responsibility to only its property owners and no Lake maintenance but with a strong voice in the County ear. In fact, an Institution Executive is likely to be soon appointed as an alliance board member while new organizations like the CLPOA cannot be members. In any case, the CLPOA board wishes all of you a Merry Christmas, Happy Holiday and Happy New Year. We hope the New Year will bring a significant increase in the legislator's attention to Chautauqua Lake and the existential threat affecting its viability and role as the Counties economic engine and cash cow. We hope lakeside legislators and the County Executive take notice of recent County election results and understand that the property owners, year around and seasonal, expect them to remedy unacceptable Lake conditions with a comprehensive plan, strong leadership, effective management, something which has been missing for decades. It's your job to do it and with that, I thank you all and I will see you next year.

Chairman Chagnon: Thank you. Anyone else wishing to address the second privilege of the floor? Anyone else? Seeing no one, I will close the second privilege of the floor and I'm looking for someone to wish us all a Happy Holidays and I saw a hand go up down front and Legislator Bankoski?
