

## **Lead-CHHP Chautauqua Healthy Homes Program – Completed Units**

### **HUD Lead Hazard Reduction Grant**

The Lead Hazard Reduction Grant Program is funded by the Federal Department of Housing and Urban Development and managed in partnership between the Chautauqua County Health Department & Chautauqua Opportunities, Inc. to address lead hazards in residential units. This program has made more than **44** Residential units in the Chautauqua County lead safe as of:  
**October 2025**

The Chautauqua County Health Department does not warranty or guarantee the current condition of any property listed. This is a list of properties that have benefited from lead hazard reduction through this grant program. This is not a list of all units in Chautauqua County that are “lead safe.” Units listed may or may not be available for rent. The units listed were deemed lead-safe as of the date listed above. "Lead Safe" means that there were no deteriorated lead-based paint at the time of the unit's lead clearance inspection. Additionally, all surfaces tested during the clearance inspection were found to be in full compliance with the Lead- Chautauqua Healthy Homes Program and Federal guidelines for safe levels of lead dust.

The residential unit and common area lead based paint components shall remain in compliance only as long as there continues to be no peeling, chipping, chalking, or flaking lead paint or other accessible lead materials. Surfaces that received remediation by paint film stabilization and/or encapsulation form a protective barrier that will only remain effective as long as the surface remains in place and undamaged. Surfaces that have been enclosed will remain safe as long as the materials covering the hazard remains intact.

It is the property owner's responsibility to keep all surfaces intact to maintain compliance. All homeowner's, landlord's and/or property managers have received US EPA RRP Certification and comply with lead safe work practices. Prospective renters or buyers should always check with the owner to see if these practices have been followed.
