Gentlemen:

Pursuant to New York State Election Law, section 34, we submit the Board of Election's Annual Report for the calendar year of 1973.

A special election was held on April 17, 1973 concerning Local Law 1 of 1973. The purpose and effect of said Local Law was to establish 13 legislative districts with 23 members, substantially equal in population. There were 130 election districts involved, an increase of 5 in the City of Jamestown due to re-districting.

A special School of Instructions for the Jamestown election inspectors was held due to re-districting on Wednesday, April 11, 1973. Classes were held at 2:00 p.m. and 7:00 p.m. Instructions were given in the Jamestown City Council Chambers. Results are as follows:

March 12th was the first day for circulating Designating Petitions. Dates for filing such petitions was between April 9th and 12th for the June 4th (Monday) Primary Election. As a result of these primary contests all 130 election districts were open on Monday June 4th from noon to 9:00 p.m. The number of voters participating by Party are as follows:

Two Party primaries occurred in 75 election districts, necessitating more complex voting machine setups for the Custodians.

Although this office does not in accordance with law, have anything to do with the printing of these petitions, we are deluged with questions on proper ways to execute them. Many of these petitions are filed with the Board of Elections. Those persons

on whose behalf petitions have been filed are then notified and they can accept or decline the designation. At this point, it has to be established whether or not a Primary Election would occur in any of the offices, and if so, prepare for it.

All Primary candidates were notified pursuant to EL ss 250-A that the voting machines which will be used at the Primary were available for inspection by the candidates or their designated representative at 7:00 p.m., Saturday, June 2, 1973 in the polling places so designated.

The dates for holding the 8th Judicial District Conventions were on September 7th and 8th, 1973 in Buffalo. Three candidates received four Party endorsements for the position of Supreme Court Justice, 8th Judicial District. The last day to fill a vacancy after declination of the Judicial Convention nomination was September 12, 1973. No declinations were received.

This office frequently receives from various individuals seeking public office, or party position, questions of procedure. It is our advice to these individuals to seek the aid of legal counsel in order to avoid any possible complexities.

Upon the New York State Legislature annual passage of the political calendar, the Board of Elections prints the calendar and voter registration information for county-wide distribution. Due to the variations in time of enactment by the New York State Legislature, this office frequently publishes both a tentative and regular political calendar.

Effective on September 1, 1973 chapter 895, Laws of 1972, now places all Village Elections under new Article 17 into the Election Law. This office also distributes a dual-dated village political calendar. The Village of Fredonia which is a charter village, has a somewhat earlier calendar of activity and election day.

Also, this office printed and distributed to all 495 candidates, Inspectors of Election and Party Chairmen, a pamphlet entitled "Certain Sanctioned Procedures and Regulations Relating to Electioneering"; Candidate Expense Forms EL 324; facsimile of the Department of Law letter by the Attorney General, Mr. Louis J. Lefkowitz, enforcing the filing of financial statements; Notice of date, time and place to inspect the voting machines being used EL 250-a; Watchers and Challengers Certificates; A list of polling places and voting machine custodians; Recanvass of Voting Machines, date and places, EL ss 274.

In preparation for the Primary and General Election, a School of Instructions for Election Inspectors and Alternates was held in the auditorium of the Hall R. Clothier Memorial Building. A total of 6 afternoon and evening classes was held from

August 27th through August 29th. A total of 471 attended the six classes (418 Election Inspectors and 53 Alternates). All Election Inspectors are entitled to be paid \$5.00 per day and mileage for attending such school EL 49-a (1).

A centralized school of instructions permits the use of the overhead projector and a voting machine. Written examinations were administered to all election inspectors and covered many of the recent changes in the Election Law.

The General Election was held on November 6, 1973. Hours of voting were from 6:00 a.m. to 9:00 p.m. The unusually long ballot for this election required the attachment of brackets to hold State proposition #1, amendments 1 through 10, plus County questions #1 and #2. It would be impossible for a voter to enter the voting machine, read the entire ballot and vote, within the three minutes maximum time allowed. Accordingly, this office disseminated news releases and pamphlets relating to the various questions, propositions, and amendments.

The day following the November 7th General Election, this office received the election supplies which were returned from all of the 131 election districts, (Ellery increased to four election districts), the bulk of which was received before noon. These districts utilized 166 voting machines. This represented 35 election districts in the county with more than one voting machine. Actually, 42 election districts should have had more than one voting machine in order to minimize long lines at the polls.

It is a lack of responsiveness by local government to problems such as this that prompted the Board of Elections to present to the County Legislature, per Resolution 242-72, a report concerning the feasibility of transferring all powers, duties, responsibility, etcetera, except School Board, Villages, Fire, and other Special District Elections, to the Board of Elections. This office would be happy to draft such enabling legislation to be presented to the New York State Legislature.

Bi-partisan teams, consisting of permanent employees began the canvass of the 166 voting machines that very afternoon. This requires personal inspection of the sealed voting machines and verification of the results as recorded by the Election Inspectors. This physical inspection was completed by Friday, at 5:00 p.m. At this time temporary help is needed annually to process the voluminous statistics in order that this office may certify the results within the mandated time.

Due to the time schedules mandated by the New York State Election law, unusually heavy demands have been made on the County Printing Department by this office. For example, Election Law ss 376, mandates the printing of Voter Registration lists for each of the 131 election districts of the newly local registered voters of October 12th and October 13th.

In 1972, the U.S. District Court rendered a decision which prohibited, as a voting requirement, durational residence in excess of thirty days before the November General Election. Therefore, this office has to be prepared to register all persons who will have resided at the legal address from which they seek to register for at least 30 days prior to election day.

Furthermore, Election Law ss 355, 149a-(28), stipulates that a qualified person could move, up to and including Friday, October 26th, thus changing his address and possibly the election district. Therefore, accurate registration lists must be printed after this date. This office is mandated per EL 376(4), for the distribution of lists, not less than six days prior to the day of election, Wednesday, October 31st. EL 376(5), compels distribution of Registration lists before the 6th day to the Secretary of State and the Attorney General.

The printer will receive in late January, data relative to the 70,790 registered voters for the completion of printed enrollments (before the first of March, 1974, pursuant to EL ss 377). Our efforts to process this data is impeded by EL, ss 86, which states that we cannot open the enrollment boxes until the Tuesday following the General Election and the process must be completed before the first day of February of the succeeding year.

Increased use of temporary employees for each of the twelve months of the year is due to the continually expanding normal and peak work load. The E.E.A. program provided us with two employees during the summer.

Concomitant with Sec. 377 of the Election Law, Sec. 405 mandates a Purge List begun in the second week in December and be completed not later than the third week in the succeeding January. All permanent records and data related to the more than 70,790 enrolled voters have to be individually examined to verify if the registrant has voted at least once in a General Election during the past two years. All those that have not must be notified by mail (4,471 individuals) of the impending cancellation of their status as a registered voter unless they fill out, sign and return the re-instatement request form within three weeks of the date of the postmark on the notification. After this three week interval the newly compiled list of registered and enrolled voters is then sent to the printer, pursuant to Section 377 in conjunction with the needs of Section 191 sub 1-a concerning Spring primaries.

Registration records under Section 381 and 516 of the Election Law are used for Village and School District elections. Election Law ss 516 (6a) states, if such village is located in a County wherein Permanent Personal Registration is required, they (Village Inspectors of Elections) shall copy such names from the registration poll records.

Effective September 1, 1973 all sections of Village Law appertaining to Village elections are transferred to the Election Law by a new Article 17 added by Chapter 895 Laws of 1972. There has been considerable discussion by the New York State Joint Legislative Committee to place Village Registration under the supervision of the Board of Elections. Presently all individuals who are registered with the Board of Elections under P.P.R. are automatically qualified to vote in Village Elections. Conversely, an individual who registers to vote under the Village registration system is not automatically qualified to vote in a November General Election. This person must personally register again under P.P.R. in order to vote in a November General Election, thus many village residents are confused and disenfranchised by this dual system. This office publishes a separate Political Calendar pertaining to the Village Elections and are available for interested individuals.

At least 8 months (March 6th) before the General Election, each County, City, Village, and Town Clerk, pursuant to EL ss 149-a, sub.30, shall make and transmit to the Board of Elections, a certificate stating each County, City, Village, and Town officer respectively, to be voted on at the General Election, including any local proposition or question known to such officer at the time of issuance of the certificate. If any officer is to be elected to fill a vacancy, the Certificate shall so state. Within the above time period the Secretary of State shall make and transmit to the Board of Elections, a Certificate stating each office above County level which lawfully may be voted for at the Election. A similar requirement by EL ss 67 is required 3 months before the General Election.

The concentration of such information in our office generates many inquiries throughout the year concerning Election Law, Petitions, Party Caucus, Primaries, General Election, A.B.C. local option, Referendum, Special Elections, School Board Elections, Fire Districts, etc.

Section 392 of the New York State Election Law, provides for a special check of all registered voters in any or all of the election districts including those previously checked. This personal check of registrants is contingent upon the written, filed request of any one member of the Board of Elections and is conducted by legally constituted bi-partisan teams. This is especially important when one recognizes the fact that one family in five moves annually and the 18-30 age group is highly mobile.

The Election Commissioners Association of the State of New York, of which we are active members, have been seeking permissive legislation allowing any registrant who moves within the County, to re-register by mail. This, we feel, with proper safeguards, would be more convenient to the registrant and the Board of Elections.

Further impetus for voter registration was granted by Resolution 85-73 of the County Legislature authorizing and directing the Board of Elections to conduct such a voter registration drive throughout the County. Many of the locations were in Senior High Schools, but open to the public with walk in registrants. Positive response in 18 year old voter registrations in May was a direct result of the impending April Special Re-apportionment Election, School Board elections, Primaries, and the county-wide B.O.C.E.S. election.

Voter registration in the field is conducted by our permanent staff and temporary help which we use to train many election inspectors. The results were as follows:

The Central Registration figure of 3,474 plus the two day local registration of 2,680 placed a total of 76,853 registrant's names on our rolls. Change of enrollment requests were 158.

Section 394 states the Board of Elections, not less than 15 days nor more than 30 days before the first day of Local Registration (October 12th), shall conduct a Mail Check of every registered voter. This entails processing 76,853 letters to the 131 election districts and notifying the registrant that such communication is a routine check to ascertain whether such voter still resides at this address. This September mailing resulted in 3,000 letters listed as undeliverable at the indicated address. Within one week (October 20th) after the conclusion of Local Registration the Board of Elections shall send similar communication (2,680) letters to every voter registered in such Local Registration period.

At this point, pursuant to the Election Law, Sec. 331, sub. 3, this Board calls upon law enforcement agencies to investigate questionable declared and actual voter residency.

Whenever such communication is returned as undeliverable, the Board of Elections forthwith shall proceed in accordance with the powers granted to it by Section 406 to determine whether such registration of the affected person shall be cancelled. This Board received 5,437 letters in 1970; 4,121 letters in 1971; 2,949 in 1972; and 3,000+ as undeliverable in 1973. Such legal determinations were made and verified in the 20 days prior to Election Day on November 6th. In addition, this office issued 395 (285 voted) Military and Military dependents ballots compared to 1,006 from the previous year.

Absentee ballots issued were 1,075 (909 voted), compared to 2,727 in the 1972 Presidential election and 1,439 in the 1971 election. Permanent physical disability voters totaled 275 (72 newly added in 1973) with 197 voting, pursuant to EL, 117-a (3a). The total requests of military, absentee, and physical disability voters was 1,745.

Pursuant to the order of Federal District Judge Edward Weinfeld, all Boards of Election in New York State were instructed to canvass all absentee ballots received or returned by 9:00 p.m. election night on November 6, 1973. In order to comply, our office made arrangements to pick up the mail in the Mayville Post Office and the Jamestown Sectional Center and counted those ballots centrally.

Due primarily to re-districting of 18,996 voters in Jamestown, 37 court orders were issued. This office does assist in initiating such action as the direct result of any newly acquired information to prevent voter disenfranchisement.

This office is in reality, an office of vital statistics of the most current information available on a County wide basis. Each and every month pursuant to Section 397, sub 1, this office receives from the public recording officers of the 15 villages, 27 towns, and 2 cities, the deaths in their respective areas in order that we may remove the deceased person from the current registration list. The number of cancelled forms due to deaths was 643; moving, etc. came to 4,196 for the year 1973. The continual updating of names and addresses as mandated by the Election Law, of Chautauqua County residents in our office results in many requests for information from the Courts, FBI, Social Security Administration, attorneys, private agencies, and individuals. This office is one source of names and addresses to the Federal and County Courts for use as potential jurors. In fact, this office provides many such services for several county departments.

An early interest in the November election was generated by the County Charter; Reapportionment; nomination of County Legislators by Party Convention; and the Voter Registration Drive conducted by the Board of Elections under Resolution 85-73.

Due to the narrow margins of unofficial results for local office, extra effort was made to certify the winners in the shortest possible time.

In every above instance there were a sufficient number of individuals already in the voting machine who did not vote for any candidate and could have changed the outcome.

This is in addition to eligible registrants that did not vote!

The day following the November 6th election, this office received the election supplies which were returned from all of the 131 election districts, the bulk before noon. These districts utilized 166 voting machines.

Bi-partisan teams, consisting of permanent employees began the canvass of the 166 voting machines that very afternoon. This requires a personal inspection of the sealed voting machines and verification of the results as recorded by the Election Inspectors after the polls closed at 9:00 p.m. election day. This physical inspection was completed by Friday at 5:00 p.m. At this time temporary help is needed annually to process the voluminous statistics in order that this office may certify the results within the mandated time.

Beginning the first day of Central Registration on December 6, 1973 and thereafter, all persons 18 years of age or older who are otherwise qualified to vote, would be eligible to register and vote at all Primary, Special and General elections held on or after December 6, 1973. This includes the right of Special Enrollment for the 1974 Primary Election for such new voters, pursuant to Section 187 and 388 of the Election Law.

There is a tendency to decentralize government in Chautauqua County by establishing branch offices in the Dunkirk and Jamestown area. Census figures reveal that the Dunkirk and Jamestown quadrants contain 30% and 50% respectively of the county population. Government exists to serve its constituents. The establishing of branch automobile license offices is such an example. This office believes such office space should be available to the electorate. Representative government begins with the Board of Elections.

Besides Chautauqua County, Albany, and Chemung adopted charters that provide for elected County Executives with wide powers to supervise the administration of their governments. When the new charters go into effect, 17 of the 57 counties outside New York City will have a charter form of government with a strong executive.
