### **Lead Program Inspection Fees**

#### **Initial Lead Rental Registry (zip code 14701) Inspection**

Includes visual inspection, dust wipe sample collection, and processing.

Primary rental unit	\$100
Secondary and each additional rental unit	\$50

#### **Clearance Inspection**

If lead hazards are identified in the initial inspection a full XRF inspection will be required.

Once remediation work is completed a clearance inspection is required to issue a Lead Safe Certificate. Inspections include dust wipe sample collection and processing.

Primary unit clearance inspection	\$75
Secondary unit clearance inspection	\$50
Subsequent clearance inspection following failure	\$50 / unit

#### **Residential Lead Inspection \$650 / dwelling or unit**

CCHD staff will complete a residential property lead inspection if requested; inspections will include:

- Individual dwelling or unit inspection with XRF device.
- Dustwipe collection and processing.
- Recommended general remediation / abatement actions based on findings.
- Information for lead safe work practices.
