Brocton-Portland Water System

-Supervisor Lewis has turned in invoices for reimbursement for maintenance and supplies within the Brocton Portland Water System.

Administrative Director Report

- The documents needed for the DOCCS reimbursement have been received and sent to the state for their review.
- After reviewing electric accounts within the district for the 2026 budget, it was discovered that one pump station within the Town of Portland is being charged by National Grid and American Power and Gas. After research and calls, the service with American Power and Gas will be terminated due to the excess amount being paid each month for electric service to this pump station. This will help with decreasing the amount paid for utilities for the district in 2026.
- The notices and certification for the Service Line Inventory per the Administrative Order have been completed on August 13, 2025. The Town of Portland and Village of Brocton are still working to complete their inventory.
